Throughout this questionnaire, the term "third party" includes any vendor, customer, representative, agent, attorney, accountant, banker, advertising agency, trade association, consultant, or others with whom the Company has transacted, or may transact business, or whom the Company has used, or may use, in the conduct of any of its business affairs.
- 3. "Value". Throughout this questionnaire, references to "something of value" or similar phrases refer to items that can include cash, cash equivalents (gift certificates), merchandise, services, loan of company assets, personal loans, offers of employment, below-market rent, trips, unusual discounts, or other benefits.
